## 2. Public Comments -

## 4. President's Report

Arlette congratulated Trustee, Michael Mark, for winning another term on the Nyack School Board (as a Trustee).

## **5. Director's Report** – on file for review.

Christy met with a roofing consultant on May 17<sup>th</sup>. The roofing consultant will provide a report in two to three weeks on the state of the roof including items that need immediate attention and approximate timespans for replacement on each section.

Several staff members have tested positive for COVID. While not a huge impact in the staffing, COVID

remains a part of our lives.

The air conditioning in the Glass Room has not been functioning since last year but will be repaired soon in anticipation of a new season of more robust in-person programming.

A contract was signed for quarterly pest control in response to a significant presence of carpenter bees. The library does encounter other nuisance pests during each season.

Christy has applied to be accepted into the Leadership of Rockland County program and was interviewed recently. If accepted she would start in September for one day per month.

Christy reached out to the Islamic Center of Rockland County located in Valley Cottage. Several members of the mosque will come for a tour on May 19, 2022. The meeting is a furtherance of a connection began earlier this year on Zoom to connect to organizations within our community.

In accordance with a Stormwater Agreement with the Town of Clarkstown the stormwater/draining system in the parking lot needs to be inspected annually by an engineering company. The system was found to be operating as designed and no work is necessary.

A full-staff meeting will be held on May 20. Christy and Ashley will train staff about the increasing occurrence of First Amendment Auditors visiting libraries as well as a review of our meeting room use and materials selection policies..
