- Ashley reported that the library won a new eco-friendly bench from Trex. To win, the library collected at least 1000 lbs. of recycled plastic over the past year. The bench, which has to be assembled, will be installed at a location to be determined in spring 2025.

Bylaws Committee -

RESOLVED, that the highlighted language in red be added to the Board of Trustees By-Laws, Article I, Powers of the Trustees, Section 1a.:

Section la. The President, Vice President, Secretary and Treasurer shall serve a term of one year from the Board of Trustees meeting following the Annual Association Meeting at which they are elected and until the conclusion of their respective terms. Tenure of these officers shall be limited to three consecutive full terms of one year each. Motion passes 5-0.

RESOLVED, that, on recommendation of the Library Director, the Board of Trustees of the Valley Cottage Library adopts the *Employee AI Use Policy*.

Melissa reported that the updated RFP for the renovation of the teen space was received from the architect in late November and reviewed by the Building Committee at its December meeting. The finalized RFP was distributed on December 12, 2024 with a response date of January 15, 2025 to coincide with the January board meeting.

Mary reported that the Building Committee recommends moving forward with the installation of a whole building generator. The current generator, which is currently past its expected lifespan, provides limited coverage in a power outage. The committee recommends that the library seek a construction grant to cover up to half of the costs in summer 2025.
