- 1. **Call to order –** Meeting called to order at 7:57 PM by Frank Dwyer, Board President
- 2. Public Comments None
- 3. Approval of the minutes of the December 18, 2024 Meeting minutes -

Moved by Jemar Ward and seconded by Arlette Mooney the following resolution, **RESOLVED** to accept the minutes of the December 18, 2024 Board of Trustees meeting. Motion passes 6-0.

## 4. President's Report -

Frank Dwyer, Board President, expressed appreciation for the Board's dedication and ongoing efforts to improve the Library's services.

#### 5. Director's Report -

Christy reported as follows:

- The original proposed furniture for the adult internet stations was too large for the designated space. A new proposed option was custom-created and will cost half of the original allocation.
- Concerns raised about potential double taxation issues for the library.
- Christy was interviewed by the Rockland County Business Journal about the Library's Community Closet.

#### 6. Treasurer's Report -

Michael Mark, Treasurer, reported on the financial status of the Library as of December 31, 2024. Surplus funds were used for parking lot repairs, leaving \$19,000 in remaining funds.

Marge McLoughlin and Arlette Mooney nominated Melissa Roy to serve as Board Secretary. Board approved 6-0.

Designation of Official Newspaper -

A motion was made by Michael Mark and seconded by Arlette Mooney that the Board of Trustees of the Valley Cottage Library designate the Rockland Journal News to be the official Library newspaper. Board approved 6-0.

2025 Board Committees -

Committees were reviewed and updated. Jemar Ward was appointed to the Finance Committee. All other committee assignments remain unchanged.

**Building Committee** -

Two of three sealed bids for the Teen Space Project that were received in a timely fashion were opened.

- Greenbush Construction: \$185,000
- Galway Bay Contracting: \$165,648

The bids were referred to the Building committee for further review and recommendation.
